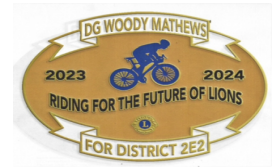




**2023 -2024 District 2-E2**  
**Drug Awareness Speech Contest Rules**  
**"An 'OLDIE' yet New Drug in Town: XYLAZINE"**



**A. Speech Subject:** "An 'OLDIE' Yet New Drug in Town: XYLAZINE"

Opioid use is on the rise in the United States but one drug, xylazine, has hit the market with a vengeance. This is not a controlled substance in the United States which makes it more illicit and lethal than fentanyl. As you research this drug, please note what it is, how it is prepared, the side effects, and prolonged effects once it is ingested. Remember to include treatments and solutions to prevent your peers from using this drug.

**B. Contest Rules:**

1. The title of the Contestant's speech is not required to be the same as the Subject for the speech. Contestants should be creative in the selection of a speech title and set the tone for their presentation with the title they choose.
2. The presentation should analyze the problem given in the subject and present solutions.
3. Research for this topic can be conducted by interviewing school officials, teachers, judges, law enforcement personnel, probation personnel, counselors, juvenile court officials, legislators, medical personnel and by using the internet and the library.
4. The topic is broad and allows the contestant considerable leeway in the selection of their solution or solutions.
5. Sources of data and quotes should be identified by title, author, and date published (year if known).
6. Creative, innovative, practical, and reasonable ideas are welcome.
7. The speech will be from five (5) to seven (7) minutes in length.
  - a. A monitor will signal contestants at five (5) minutes and at six and one half (6½) minutes.
  - b. At seven (7) minutes, the monitor will signal and five (5) points will be deducted from the contestant's score.
  - c. A speech of less than five (5) or more than seven and a half (7 ½) minutes will be disqualified.
  - d. Should a disturbance occur during a speech, the contest monitor will adjust the time accordingly.
8. Notes, cue cards and video equipment may not be used at District or MD-2 State contests.  
Pre-recorded speeches are not allowed for online contest.
9. ALL MD-2 contests shall be conducted in the English Language.
10. Judges should be persons who are knowledgeable of the subject.
11. Order of appearance before the judging panel will be determined in advance at the direction of the Contest Chair.
12. The contest area must have good acoustics, be free from outside noises and disturbances, and have controlled access.
13. Contestants shall remain outside the contest area until invited to enter by the Contest Official.
14. The audience will be informed before the first contestant to not applaud at the end of the speech and reminded before each contestant delivers his/her speech of the same requirement.
15. The audience will be asked to turn the sound off any cell phones or other electronic devices during the competition.
16. Failure to comply with this rule could result in disqualification of a Contestant at the discretion of the Contest Official.
17. The winners will be announced during the Luncheon at noon.
18. The 1st place winner must be present to deliver his or her speech at that time.

**C. Awards**

1. The 1st place winner will receive a \$1,500.00 scholarship.
2. The 2nd place winner will receive a \$1,000.00 scholarship.
3. The 3rd place winner will receive a \$500.00 scholarship.
4. To collect the scholarship award, the Contestant must complete the following process:
  - a. Contestant winners must complete a Scholarship Request Form along with proof of registration information from a university, college, junior college, or vocational school.

- b. The scholarship awards must be collected no later than two years following the recipient's graduation from High School.

#### **D. Rules of Eligibility for Contestants**

1. A contestant must submit a completed entry application (containing all requested signatures) and associated documents to the Lions District 2-E2 Contest Chairperson prior to the entry deadline.
2. A false statement on the entry application, or associated document, will result in the disqualification of the Contestant.
3. When a first placed district contestant is unable to participate in the MD-2 State contest, the first alternate contestant from that District, when approved by the MD-2 State Contest Chairman, may enter the contest.
4. Each contestant must be an enrolled student in a public high school or comparable educational program, located in Texas.
5. Each contestant must be a junior, senior or immediate graduate at the time of the District 2-E2 contest.

#### **E. Responsibilities of Contestants:**

1. Each Contestant shall be required to submit the following to their sponsoring Lions Club by December 1, 2023. The sponsoring Lions Club is to forward the information to Drug Awareness Council Speech Coordinator, Lion Darendra Rangel by December 15, 2023.
  - a. Four (4) typed copies of Contest Application (If you win: State forms are mandatory and are to be completed online and printed from the fillable form on the State Website: [www.texaslions.org](http://www.texaslions.org). **No handwritten applications or forms are accepted.**
  - b. Two 4 x 6 or 5 x 7 photographs that are of the head-and-shoulders, glossy, color and high resolution (300 dpi or better).
  - c. The printed copy of the speech will not be used for judging purposes, but shall be used for publications and contest promotionals. Failure to supply the printed copy of the speech will result in a forfeiture of any awards earned in the contest.
2. Attend the District 2-E2 contest on January 20, 2024 at Irma Marsh Middle School, 415 Hagg Dr., Ft. Worth, TX 76114.
3. The 1st place winner will attend the Lions MD-2 Texas State Convention in Ft. Worth, TX on May 4, 2024.
4. The 1st place winner is required to attend an online orientation held on April 27, 2024 at a time set forth by the State Chair.
5. Exemption of this requirement may be granted prior to the meeting by their State Contest Coordinator of the State Contest Chair.
6. Contestants will have the opportunity to visit the presentation area at the District contest and ask any questions they may have about the contest.
7. All contestants must be available, upon request to participate in Lions District 2-E2 events and activities during the period from immediately after the contest until the end of the following year's contest.

**1.Speech Subject:** Opioid use is on the rise in the United States but one drug, xylazine, has hit the market with a vengeance. ## **2. Contest Rules**

- a. The title of the Contestant's speech is not required to be the same as the Subject for the speech. Contestants should be creative in the selection of a speech title and set the tone for their presentation with the title they choose.
- b. The presentation should analyze the problem given in the subject and present a solution or solutions to the problem.
- c. Research for this topic can be conducted by interviewing school officials, teachers, judges, law enforcement personnel, probation personnel, counselors, juvenile court officials, legislators, medical personnel and by using the internet and the library.
- d. The topic is broad and allows the contestant considerable leeway in the selection of their solution or solutions.
- e. Sources of data and quotes should be identified by title, author, and date published (year if known).
- f. Creative, innovative, practical, and reasonable ideas are welcome.
- g. The speech will be from five (5) to seven (7) minutes in length and be consistent with the written essay submitted for the contest.
  - i. A monitor will signal contestants at five (5) minutes and at six and one half (6 1/2) minutes.
  - ii. At seven (7) minutes, the monitor will signal, and five (5) points will be deducted from the contestant's score.
  - iii. A speech of less than five (5) or more than seven and a half (7 1/2) minutes will be disqualified.
  - iv. Should a disturbance occur during a speech; the contest monitor will adjust the time accordingly.
- h. Notes and cue cards may not be used at District or MD-2 State contests. Prerecorded speeches are not allowed for online contest.
- i. All MD-2 contests shall be conducted in the English language.

- j. Judges should be persons who are knowledgeable of the subject.
- k. Order of appearance before the judging panel will be determined in advance at the direction of the State OFY Chair.

### **3. Awards**

- a. The 1st place winner will win a \$3,000.00 scholarship.
- b. The 2nd place winner will win a \$2,000.00 scholarship.
- c. The 3rd place winner will win a \$1,000.00 scholarship.
- d. To collect the scholarship award, the Contestant must complete the following process:
  - i. Contestant winner or runner-up must complete the Scholarship Request Form along with proof of registration information from a university, college, junior college, or vocational school.
  - ii. The information should be sent to the state office along with any supplemental information needed by the institution (i.e., scholarship forms, etc). Send request for payment to:

- 4. Payment will be made directly to the scholarship/financial aid office of the designated school.
- 5. The scholarship awards must be collected no later than two years following the recipient's graduation from High School.

### **6. Rules of Eligibility for Contestants:**

- a. A District may sponsor no more than one Contestant in each contest by submitting a completed entry application (containing all requested signatures), associated documents, and the entry fee to the MD-2 Contest Chairperson prior to the entry deadline.
- b. A false statement on the entry application, associated document, or violation of contest rules causes disqualification of the Contestant, with the entry fee being forfeited.
- c. There shall be no refund of any entry fee.
- d. Each contestant shall have placed first in the district contest during the current Lions' year.
  - i. When a first placed district contestant is unable to participate in the MD-2 contest, the first alternate contestant from that District, when approved by the MD-2 Contest Chairman, may enter the contest using the original entrant's sponsorship fee.

- ii. If District has only one contestant, District may sponsor the contestant in the MD-2 Contest.
- e. Each contestant must be or have been a regularly enrolled student in a public high school or comparable educational program, located in Texas.
- f. Each contestant must be a junior or senior at the time of the MD-2 contest.

## 7. Responsibilities of Contestants

- a. Each Contestant shall be required to submit the following to his or her sponsoring Lions Club and/or District.
  - i. **Four (4) typed copies** of State Contest Application (mandatory to be completed online; no handwritten applications will be accepted).
  - ii. **Two (2) high quality wallet/passport photographs (such as current school picture)** that are of the head-and- shoulders, glossy and in color. No paper copies of photos will be accepted, must be on photo paper. Photos not meeting this requirement may not be able to be included in the convention or contest souvenir booklet.
  - iii. Signed Copy of the Code of Conduct and Chaperone Guidelines for **the Winning Contestant.**
  - iv. **Medical Power of Attorney** designating his/her Chaperone as the Primary Responsible Party for the **Winning Contestant.**
  - v. **Typed Copies of the Speech. Four (4) typed copies of the speech** will be required for judging purposes and will be used for publications and contest promotion purposes. **Changes to copy of speech are not permitted once received by State Contest Coordinator.**
- b. The winning contestant must agree to be available at the State Opportunities for Youth Luncheon and upon request to participate in Lions MD-2 events and activities during the period from immediately after the contest until the end of the following year's contest.
- c. **Orientation** will be held on **Saturday, April 27, 2024, and the Contest will be held on Saturday, May 4, 2024,** at times set forth by State Contest Chair.
- d. Prior to orientation and the contest, contestants, parents, and Sponsoring Lions Club contacts will be provided with additional instructions by the State Contest Coordinator.

- e. **Online Contest.** Contestants must be able to participate in Orientation and the contest using **online** live audio and video communication tools. **Zoom** video conferencing will be used for the contest.
- f. Basic guidelines for the contest are as follows:
- i. Contestants must have a computer or access to a computer with a wi-fi connection, video capability (webcam) and microphone to ensure that contestant's gestures and facial expressions will be captured by their camera and their voice will be clearly captured by the microphone while delivering their speech.
  - ii. Contestants will be sent an email invitation by the State IT Chair to participate in the contest and be ready at their designated time.
  - iii. Contestants must wear business attire for the online contest.
  - iv. Contestants' speaking area must be free of distractions, noise and if necessary, the State Contest Chair will advise contestants on additional lighting needs.
  - v. Contestants' speaking area should allow for maximum view of contestants without sacrificing audio quality while presenting his or her speech.
  - vi. Once a contestant presents his or her essay or speech, he or she will be placed in a waiting room until the conclusion of the contest.
  - vii. If technology fails during the contest and the State Contest Chair determines that the contest can no longer continue, the State Contest Chair may pause the contest until the technology issue is resolved. A contestant may resume his or her speech or essay at the point at which the technology failed.
  - viii. After the conclusion of the contest and the results have been determined, all contestants will be invited to rejoin the online contest room, at which time, the 1st Place, 2nd Place, and 3rd Place Winners will be announced by the State Contest Coordinator.

ix. First Place Winner will be required to present his or her speech **at the MD-2 Texas Lions Convention Opportunities for Youth Luncheon on Saturday, May 18, 2024, in Amarillo, Texas.** First Place Winners who do not attend the State Convention to present their essays will forfeit their scholarship award unless there is a medical or family emergency. High school graduation or school trips do not qualify as an emergency.

x. All contestants will be recognized and receive a certificate of participation. In addition to scholarship awards, winning contestants will receive an award and a winner's certificate.

## **8. Responsibilities of the Sponsoring District**

- a. An entry fee of \$250 to be attached to each participant's application. Check to be payable to Texas State Convention Fund.
- b. The sponsoring district must make sure all documents listed above (Items 7 (a)(i-v) are completed, have all required signatures, and are sent to the Drug Awareness Speech State Coordinator. The deadline to postmark all applications will be Monday, April 15, 2024, for all Districts.
- c. Complete Sponsorship District Responsibility List and attach to contestant's application/contest package. This is mandatory.

## **9. Chaperone/Sponsoring Club and or District Responsibilities**

- a. Winning contestant shall be accompanied by a parent, guardian, or designated chaperone from their sponsoring club or District to the convention.
- b. The Texas Lions MD-2 State Convention will be responsible for providing one night's lodging before the contest as well as the meal during the Youth Luncheon at the MD-2 State Convention for the winning contestant.
- c. The sponsoring District shall be responsible for all expenses not paid by the MD-2 State Convention for their contestant.
- d. Comply with requirements as set forth in the Texas Lions MD-2 Opportunities for Youth Contest Chaperone Guidelines.
