- 7. Welcome and Comments: DG Vince Rosen welcomed all and reiterated his thanks for those helping to pull this meeting together. There are 129 Lions in Attendance, including 42 Cabinet Members. Lunch for 86 was provided by the Colleyville Lions Club.
- **8. Resolutions & Recognitions: First Resolution** -Members of Colleyville Lions Club recognized as the Host Club for this meeting. **Second Resolution** The Crown of Life Lutheran Church as the Host Venue for this Cabinet Meeting. First and Second motions to accept these resolutions, all voted to approve. (See attachments 1 & 2.)
- **9. Cabinet minutes of Prior Meeting:** Deb Cashen, Secretary submitted minutes from the April 13, 2019 Cabinet Meeting for approval. PDG Don Noblit made the motion to approve the minutes as submitted. PDG Bob Mitchell seconded the motion. All voted to approve.
- **10. Treasurer's Report:** PDG Don Noblit commented a positive of \$2,078 for this year and submitted the Treasurer's Report for approval. PDG Tom Hayford made the motion to accept the report as submitted. PDG Jeanne Adkison seconded the motion. All approved.
- 2019 2020 Budget submitted by PDG Don Noblit (standing in for Sean Bryan). Julie Camacho made the motion to accept the budget as submitted. Doug Martin seconded the motion. All approved. (See Attachments 3-7.)
- 11. Constitution and By-Laws: Reported by DG Vince Rosen Mistake was made last year. We made modifications to bylaws letting Presidents, Secretaries and Treasurers from the clubs vote. That was passed in January, but unfortunately it was not on the ballot at the convention so it does not become effective until that is done. DG Vince Rosen read the following rules written by PDG Tom Westerman: Standing rules extending voting privileges at District 2-E2 Cabinet Meetings to members of the International Family; Past District Governors; and Club Presidents, Secretaries, and Treasurers.
- Rule 1 Voting Privileges are extended to an International Family Member, Past District Governor, Club President, Secretary, and/or Treasurer from a 2-E2 Lions Club in attendance at a District 2-E2 Cabinet Meeting.
- Rule2 The International Family Member and/or Past District Governor must be a current member of a 2-E2 Lions Club in Good Standing as defined in the District 2-E2 Standing Rules.

Rule 3 – The District 2-E2 Club President, Secretary, and Treasurer must have been duly elected and a current member of a 2-E2 Lions Club in Good Standing as defined in the District 2-E2 Standing Rules. (See Attachment 8.)

PDG Ron Layland made the motion to put this into effect until the convention in April, 2020 when the bylaw change will be put on the ballot for voting by the District. The motion was seconded by 1VDG Mary Layland . Discussion included whether or not this included Past District Governors. DG Vince Rosen stated - Past District Governors must be a current member of a Lions Club in good standing. All approved.

White Cane – PDG Dave Schneider: White Cane Safety Awareness day Oct. 15. This is different from White Cane project of the Organ & Eye Bank which is used for eye surgery, etc. Safety day has to do with National awareness of blind people in American society, education and commerce. White Canes were used as early as 1920's. In 1930 Lions of Detroit picked that up as a project and Lions throughout the country supported, until 1964 when President Lyndon Johnson made October 15th the official White Cane Day every year. Paul Swartz is a member of the North Texas White Cane Safety Day which meets in Ft. Worth. Michelle Greco is also on that committee. This year's celebrating is at the Kimball Art Museum downtown. White Cane is no longer getting grants from the private sector, so needs support from local Lions Clubs.

The ERC has just completed an outstanding year in which we were able to process and ship over 100,000 pairs of eyeglasses to missions around the world. We couldn't have made this goal without the help of many volunteers and the generosity of several clubs who purchased additional lensometers for use in the processing area. We now have a total of 9 lensometers in operation allowing us to utilize additional volunteer help and produce maximum output.

In addition, 50 of the 80 Lions clubs in District 2-E2 contributed 100% money to the ERC for our operation. Several clubs donated 200-700%. We are very thankful for their support. Two out of state recycling centers are being forced to close due to lack of funding. The ERC budgets its operation on 100% club contributions only, and your support keeps us open to serve. Please remember the ERC when your club writes its 100% checks.

We have several large non-Lion volunteer groups who have signed up to come in on Saturday afternoons and they have overtaken the Lions in service hours. This past year we had 41 of the 80 Lions clubs work a total of 1022 hours, while our non-Lions volunteers have worked 1447 hours. Our 2019-2020 goal is to have all 80 Lions clubs to volunteer at least once per year to come in to work. The work is easy, mostly sitting, in an air-conditioned room and should not overstress anyone.

The ERC is currently open on Saturdays, from 9am – 3pm. We have reserved Saturday mornings for Lions club volunteers so that every club can participate. If clubs would prefer coming on a weekday/evening to coincide with their club meeting, arrangements can be made for a director to be available at a time of their choosing. 2-e2 Lions District Lion Quest Report

This year the Texas Legislators provided our well-deserved teachers a raise; however, the legislators also issued and passed House and Senate Bills which demand a GREAT increase in teacher training which must occur early in the 2019-2020 school year, yet did not provide addition calendar days to enable implementation: The professional training demanded:

- 1. Mental health and substance abuse—Staff
- 2. Awareness and prevention of sexual abuse and maltreatment— Staff
- 3. Identifying and reporting sexual abuse, human trafficking and maltreatment—Staff
- 4. Seizure awareness and first aid—Nurses
- 5. Concussion training—Nurses
- 6. Health care professionals and human trafficking—Staff
- 7. Cybersecurity training—Staff
- 8. School safety and mental health—Staff
- 9. Extracurricular safety training—Staff

How does this impact the expansion of Lions Quest? With the demands by the legislators demanding this additional professional training, Texas schools will be resistant to the launching of Lions Quest this Fall. I have had a Lions Quest Training cancelation, yet the Executive Assistant Superintendent requested Lions Quest Training in the Fall of the 2020-2021 school year.

Those schools which already have Lions Quest in place will be able to utilize numerous skills taught in Lions Quest to meet some of the Legislative requirements. From August 15 – 17 I will be in Oak Brook for the Lions Quest Advisory Committee Meetings, and in September I

will be attending a meeting discussing the specifics as to how best to move forward. As soon as I get this information, I will provide the information to 2-e-2 School Districts and the Council of District Governors.

Texas Lions Eyeglass Recycling Center

Report to the District 2E2 Cabinet July 27, 2019

District Governor Vince Rosen:

The Texas Lions Eyeglass Recycling Center (TLERC) had a record 2018-2019 Lions year providing over 2 million glasses to missions around the world. Receipts of used glasses collected by Lions, corporations and youth service groups such as the Boy Scouts remains strong and is increasing. Service hours to process the glasses dropped considerably due to access to prison labor being stopped for a remodeling project but should be back at full operating strength this year.

The TLERC is facing some fiscal hurdles associated with the growing demand for glasses and the service hours shortage mentioned above. Each district governor is being asked to help promote the TLERC to the clubs in their district.

We are confident the 2019-2020 Lions year will see the TLERC continue to grow in the ability to provide glasses to those in need.
