 - 6. Resolutions & Recognitions: Resolution –** Lions of District 2-E2 met June 13, 2020 at the District Convention and Fourth District Cabinet Meeting in the City of Colleyville, Texas. The Colleyville Lions Club served as the Host Club for this Convention and Meeting. (See Attachment 1 for more details.)
 - 7. Welcome and Comments:** DG Vince Rosen welcomed all and reiterated his thanks for those helping to pull this meeting together under such challenging circumstances. There are 34 Cabinet Members in Attendance.
 - 8. Cabinet minutes of Prior Meeting:** Deb Cashen, Secretary submitted minutes from the January 18, 2020 Cabinet Meeting for approval. Juneria Berges made the motion to approve the minutes. PDG Bob Mitchell seconded the motion. Minutes accepted.
 - 10. Treasurer's Report:** Don Noblit noted a positive of \$575.72 for this year and submitted the Treasurer's Report for approval. PDG Ron Layland made the motion to accept the report as submitted. Juneria Berges seconded the motion. All approved. (Attachment 2)
 - 11. Budget Report:** Sean Bryan, nothing to report yet.
 - 12. Constitution and By-Laws:** All recommended changes are reflected in the Constitution and By-Laws per PDG Tom Hayford and they are on the website.
 - 13. GMT:** PDG/GMT John Paul Burnett reported we have 3 or 4 people working to assist in forming Frisco and helping to grow Prosper. This GMT is working with you to build membership this year as it has been in the past. We need to focus on getting people involved that want to be involved. If you have any leads or need some help get in touch with PDG John Paul Burnett.
- Women's and Family:** Lion Rose Marie reported no information at this time.
- Campus Clubs:** PDG Bob Carlson reported no information at this time.
- GLT:** PDG Suzi Schneider reported the Leadership Meeting conference stalled due to virus. We are seeing Zoom meetings as a result. She will be looking into having more Zoom meetings to continue getting together.

GST: Doug Martin reported – Our District had 615 activities reported, 126,186 people served (down from last year), but given the situation that is understandable. We gave 24,751 Service hours with 78.26% of clubs reporting. Beginning this year 200 million people to be served worldwide. As of this year we served 199,829,714 people worldwide. May reach 200 million this year. Thanks to all for reporting service hours this year. (See Attachment 3 a-b for more details.)

DG Vince Rosen reported we started the year with 70 clubs and currently have 66 clubs, so that percentage this year instead of 78% is 84% of our clubs that reported activities, which is a record. The goal was 50%, and LCI asked us to do 60%, so we have surpassed our goal.

Unfortunately, Pottsboro is closing and the three members will move to the Sherman Evening Club. Whitesboro will hold their first meeting this week. Gainesville has been meeting at their regular place, but no regular activities. Dennison has not met yet.

4 – Celina New Century, McKinney, McKinney Morning Pride, Princeton, Prosper – Charlie Brown: McKinney Morning Pride will be meeting Tuesday and have had some Zoom Meetings. McKinney Noon Club has been meeting on Zoom. Princeton is shut down for the summer.

5 – Flower Mound Irving Indian, FM 407, Highland Village, Lake Cities, Lewisville, The Colony - Emily Rohne: Unable to contact a few clubs. The Lewisville Club has been meeting via Zoom. 15. ENTITY REPORTS

Texas Lions Camp – PDG John Paul Burnett – Texas Lions Bus has around \$20,000 which will not be used this year. Hopeful to be able to use them next year.

TLC Directors – Robert Duckworth reported no workday weekends, but shirts can be obtained online and sold to earn money for your clubs. The short sleeve is \$5 and the long sleeve is \$10. Campers that registered will be eligible for the virtual camp program this summer. Go ahead and make contact with TLC to get new campers registered for the virtual program. The Virtual Camp will be engaged for the future for those unable to attend the camp for one reason or the other.

LOEB – Emily Rohne: Vision assistance – conference calls, Zoom meetings. LOEB is welcoming 5 new members, Lions Mark Talbert, Philo Waters, Bill Ayar, Bob Appel and Russell Wheeler. LOEB made the decision not to loan out any vision equipment at this time. All equipment is kept in our central location in Keller. We feel it is not safe for our members to be doing screenings until such time at 6 feet social distancing is no longer recommended by the CDC. (See Attachment 6 for Full Report.)

JC Hyer – Woody Mathews -No camp this year due to Covid. Will have a full report in July.

TLF – PDG Ron Layland: District 2-E2 has had a good year despite Covid-19. We have 47% of our clubs who have become 100% contributors. Because of this our District heads the state in giving with \$16,390. We are currently 1st place in Giving and in 1st place in receiving. Many thanks to everyone. (See Attachment 7 for Full Report.)

DAC President –Jim Byrom: No Report

Leader Dog – Paul Richards: Dogs change lives. Encouraged all clubs to contact him for presentations. After the last 3 months they are both ready to go everywhere. Incentives for donating to Leader Dog: clubs get to choose the name of the leader dog sponsored. You can sponsor for \$500 but all donations are appreciated. The goal this year is to get to every club in our district.

LCIF Chair – PDG Tom Hayford: The 3-year campaign has been extended to June, 2022 due to Covid – 19 challenges. We have collected \$152 Million towards the \$300 million goal. As of this date LCIF has distributed the following to combat the Covid – 19 crises: 257grants totaling \$4,406,432.40 of which was designated to the U.S. Melvin Jones plaques are in suspension because LCI has shut down but you can still get a letter of congratulations. PDG Charlie Bethards will be taking this position next year. (See Attachment 8 for Full Report.)

WSB Chair – PDG Charles Bethards: World Services for the Blind seeks to provide those with low or no vision, "sustainable independence" (life skills, job skills, etc.). Camps were cancelled but WSB stayed open. Contributions slowed down and services have grown exponentially. (See Attachment 9 for Full Report.)

ERC – Lion David Gramm: The ERC closed down due to Covid – 19 because the facility could not accommodate social distancing. Last year there were 102,00 glasses shipped. This year we were up to 80,000 by March. We will reopen on August 8th but Saturday mornings until then will be open for eyeglass drop offs only. All will be sanitized and volunteers screened before each volunteer group. We are meeting on Zoom. Our budget is based on the membership in the District. Our membership has been down. We collected our 100% this year due to the generosity of a few clubs who donated more than 100%. Please consider us this year and get those donations in.

Sports Extravaganza – PDG Tom Westerman: No Report

Lions Quest – Juneria Berges: Clubs can have a service project that will cost clubs and participants absolutely nothing. Share with all organizations in your community. Children and Young adults can benefit from these virtual Lions Quest lessons. (See Attachment 10 for Full Report.)

MD-2 TLERC – Jim Cook: The ERC for state is still functioning on a limited basis in Midland. Missions are not leaving but 50% glasses are still going to Mexico. No money is set aside to go to Midland, so we need some help. We would like every club to be a focus club. Available clubs sponsor a hole in the golf tournament in Longview to help the ERC.

Convention Chair – PDG John Paul Burnett: That person assists the governor in doing what you are doing right now. I wouldn't have a job without you. However, my position is available anytime anyone wants to take it. We welcome your feedback to help us provide the best possible experiences attending District meetings and conventions. Convention Chair Assistant – Dr. Pam Eckmann: Since we were not able to have a convention this year, she has lots of Christmas stuff available for those who would like some. There will be some giveaways and we will sell some at the next two conferences. All donations are accepted.

Credentials/Directory/Elections – PDG Carolyn Gramm: Thank you to all the clubs that submitted their delegates by email. Directory need rosters for Entities for next year's directory.

Elections Chair - PDG David Gramm: Everyone on the ballot was elected with over 90% approval rate. Congratulations. Start thinking about positions for next year.

Leo Chairperson - David Phelps: No Report

Newsletter – Deb Cashen: As of next year, I will be your Communications Director. Marcia Mathews will be your new Secretary. A Quarterly Newsletter will be published at the beginning of each quarter. Notifications will be sent in advance to encourage clubs to submit information. Deb will also be keeping the lions2e2.org website up to date.

19. New Business – DG Vince Rosen: First discussion – the Council of Governors 2020-2021, Mary volunteered our District to host the November Council of Governors meeting here in 2E2. We will have to budget that money. We need our council to approve. Jim Coleman made the motion to approve the budget to host the Council of Governors meeting in our District in November, 2020. Second VDG Stan Hall seconded that motion. Motion passed.

Second discussion – PDG John Paul Burnett and DG Vince Rosen have discussed due to the fact that we did not have any disasters in our District this year. Today we have \$47,629 in the Alert Fund. We are proposing to donate (from the District) \$1,500 to \$2,000 to the Food Banks to help supply food for those that need it in each of the ten counties in our District with our 66 clubs. We will talk to each club to discover where those donations should be made in their county. This is great for Lions to do more in the community since we haven't been able to do much the last three months. Club representatives will accompany those bringing the checks to the Food Banks in each county.

Lion Don Noblit made the motion to donate \$20,000 from the Alert Fund to be distributed among 10 counties as designated by the clubs in that county. The motion was seconded by J Craddick, President of the Bridgeport Lions Club. Discussion - Some counties have Food Banks and others have organizations that serve a larger presence in the county. We are looking for county representation. We want to be proactive in supporting food banks, replacing their supplies. Emails will be sent out to the Presidents and Secretaries in our District to solicit feedback as to where those funds would best benefit the counties. There was a call for the question. Motion passed.

20. Closing Remarks – PDG Vince Rosen thanked all for attending the 4th Cabinet meeting and hope all received information that will help their clubs make a difference.

Vision Assistance-

The LOEB reviewed and approved a donation to assist a woman that needed bilateral cataract surgery. This client was sponsored by the Bridgeport Lions Club. Unfortunately, there were many delays due to misunderstandings about how the process worked and delays with paperwork. There was also delays because the LOEB requested the club get multiple quotes for the service, since the initial quotes were nearly twice what we had received for previous applications for assistance. The final delay was due to the Covid-19 pandemic and providers not being able to perform elective surgeries.

The LOEB has no new or pending requests currently.

Vision Screening-

Since January 2020 there has been a total of 13 reported screening events. The last screening events that was reported were in March. Multiple events were cancelled. The LOEB has not loaned out any equipment since March.

World Services for the Blind (WSB) Report

WSB is an organization based in Little Rock, Arkansas that seeks to provide those with low or no vision, "sustainable independence" (Life skills, Job skills, etc.). The poster child for WSB is their CEO and Pres., Sharon Giovinazzo (in my view).

What impact has the pandemic had on WSB? You can look at this from 1 donations and 2 services needed or provided. Donations from Lions appear to be down, somewhat understandable as most of the Lions fundraisers are down. From services needed or provided it has been a good story. WSB was the only such facility that stayed "open." The on-campus clients had housing, food etc. and about 62% of WSB on campus clients are otherwise homeless. The online programs that WSB needed or provided are up "exponentially" with the travel and face to face activities being restricted. WSB, Sharon, is working with OK, MO, GA, NY to add or enhance online programs. WSB has received a significant grant from AR to upgrade their on line programs.

The Capital Campaign, kicked off in the fall of 2018, is raising funds to replace/repair HVAC systems on the WSB campus (6 buildings). These systems are over 70 years old and badly in need of replacement or updates. The Kumpe building has been completed and another building has been started. Of the \$3.3M goal. Over \$2.8M has been pledged/raised and thus, the campaign needs another \$400K. Any contributions are most welcome.

In 2018-19, MD2 contributed over \$28K, down from \$37K in 17-18. So far in 2019-20, MD2 has contributed \$37K, which is significantly above last year and about equal to 17-18. The pandemic seems to have slowed contributions as there was only \$7.5K for MD2 in Jan-Jun 2020. 2-E2 contributed \$8.2K of the \$37K or over 22% of the total..

The awareness (fundraising) tour of MD2 & 2E2 by our WSB CEO, Sharon Giovinazzo, was sidelined due to Covid-19 restrictions/concerns.

WSB has begun publishing a newsletter. To sign up for the newsletter go to <https://www.wsblind.org/media-center> and fill out the registration request.

From our CEO, Sharon while 70% of visually impaired are unemployed, 85% of those who complete a vocational program at WSB are placed. For the 95 people placed by WSB in the last year the savings in Government aid plus taxes paid over a 20-year period is over \$41M.

If you want to learn more about WSB, I would also be happy to provide a program for your club.

Diabetes Awareness and Action Chair
Report for 4th Leadership Meeting – District 2-E2
June 13, 2020

1. In February, prior to the COVID-19 lockdown, I received an email from LCI regarding a project of focus groups to identify unmet needs and critical issues of persons living with diabetes. Before I could take action, we were locked down.
2. In March, I was invited to join a Facebook group called Lions Fight Diabetes, which I am monitoring for ideas.
3. Several activities for the spring including a Walmart Wellness day in April and the American Diabetes Associations walk in June were cancelled. These would have provided opportunities for service. I continue to monitor these activities, but many of them have gone online.
4. With all the in-person summer camps closed, the ADA is conducting an online camp for children with diabetes. I had a flyer on this posted online and forwarded it to diabetes-related groups.
5. I continue to look for ideas and opportunities for large scale diabetes projects for which we may get grants from the LCI Foundation. Some of these require multi-district participation, but there is not much cross-district communication in the diabetes area.
6. I have become the coordinator of speakers for my club, and am trying to beef up speakers in the five Lion focus areas, including diabetes.
